eoGenius units are designed for installation in both open air or protected environments. The product should be installed by a certified electrician and uses industry-standard mechanical fittings and electrical connections. EO Charging can, in some territories, provide a turn-key service for the installation and commissioning of charge points. Note that to validate the product warranty, installation shall be done in accordance with EO Charging's guidance and all relevant legislation.

Compatibility

eoGenius units are compatible with the Mode 3 charging standard and suitable for charging all electric cars currently on the market.

Warranty

All correctly installed EO Charging hardware is covered by our thirty-six month limited warranty. Any hardware failure should be promptly reported to us, ideally by email to support@eocharging.com, or by calling our support team on 0333 77 20383 quoting the serial number, location of the product, and giving a brief description of the failure.

Our support team will then investigate, and attempt to remotely resolve the issue. They may ask you to provide additional information to assist in this.

If the issue cannot be resolved remotely, and the product is in warranty, we will make arrangements for one of our team to visit the location and, if the issue is a result of any shortcoming in design or manufacture it will be made good free of charge or, at our option, exchanged for a replacement product.

If we attend site, and the fault is not a result of a shortcoming in design or manufacture of our product, we will make reasonable attempts to suggest what the issue is, and propose a resolution which may have a fee associated with it. A call out fee will be applicable where our product is not at fault.

Access Control

When a Genius is connected to an eoHUB and the host restricts charge point access, users will begin charging by plugging in and using the EO mobile phone app to authenticate the charge. For safety, power is only supplied to compatible connectors.

Pay As You Go Compatible

eoGenius chargers (when connected to an eoHUB) are compatible with our Pay-As-You-Go system, providing a revenue to the host.

User instructions

Instructions are displayed on signage next to the charger as well as the mobile app. This will guide drivers through the process.

Connected

eoGenius charging stations are connected to the internet via the eoHUB. The eoHUB connects to the internet by an hardwire ethernet connection or a 4G router
